8.5	<p><b>Planning Applications</b></p> <p>2/2017/0369 – Tallentire Hall, Tallentire, Cockermouth, CA134 OPR – Listed building consent to insert steel frames to strengthen overstressed beams over the bay windows. No objections.</p> <p>HOU/2017/0178 – Tallentire Hall, Tallentire, Cockermouth, CA13 OPR Post and rail fencing to be erected to side of garden. No Ojections.</p> <p>2/2017/0416 – Limetree House, Dovenby, CA13 Listed buildings consent for the installation of flood barrier mounting brackets in three external doorways. – No objections.</p>

<b>13.5</b>	M Sport – There was excessive noise from the site on 6 <sup>th</sup> September, well exceeding the allowable levels. Cllr Farebrother will follow this up with Allerdale Borough Council and feedback at next meeting.
